WHEREAS, the State of Minnesota, pursuant to the advice and request of the Minnesota State Board of Pharmacy, is a party plaintiff in four suits pending in the District Court of Ramsey County, Minnesota, entitled State of Minnesota -v- Fuller Brush Company (No. 295844), State of Minnesota -v- J. R. Watkins Company (No. 295878), State of Minnesota -v- W. T. Rawleigh Company, et al (No. 295879), and State of Minnesota -v- Nutrilite Products, Inc., et al (No. 295880), and

WHEREAS, the Minnesota State Board of Pharmacy is obligated by law to regulate the wholesale and retail sale of drugs, medicines, chemicals, and poisons in the State of Minnesota, and the activities and business of said Board require the consultation and advice of an attorney, and it appears that the public welfare will be promoted thereby, and the request for the services of such an attorney having been made in writing,

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, THAT I, WALTER F. MONDALE, ATTORNEY GENERAL OF THE STATE OF MINNESOTA, by virtue of the authority vested in me by statute, do hereby constitute and appoint WILLIAM W. ESSLING, Saint Paul, Minnesota, to be a Special Assistant Attorney General in the matter of the handling, conduct, and management of the aforesaid litigation, such other litigation as may, from time to time, arise, and to consult with and advise the said Minnesota State Board of Pharmacy. His compensation therefor shall be paid out of the funds of the Minnesota State Board of Pharmacy upon verified claims therefor presented to said Board by the Appointee. His compensation is hereby fixed at the sum of Seventy Five (\$75.00) Dollars per day. The compensation so fixed shall continue until otherwise determined. Said Appointee shall serve at the pleasure of the Attorney General, or until this appointment shall be revoked, or otherwise terminated in accordance with law.
