

OFFICIAL NO. 137

An Ordinance authorizing the purchase of
Three in Block 150 of Village, to the
Village of Lake Street.

THE VILLAGE COUNCIL OF THE VILLAGE OF LAKE STREET, MINNESOTA, DO HEREBY:

Section 1. That pursuant to that certain petition signed by all of the owners of Lots One (1), Two (2) and Three (3) in Block One Hundred Fifty (150) of Village, in Washington County, Minnesota, containing less than two hundred acres, abutting on a westerly side of the Village of Lake Street, requesting the annexation of said land to said Village, said petition having been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Lake Street are hereby extended to include said land described by the following boundary lines:

Commencing at the Northwesterly corner of Lot Three (3) in Block One Hundred Fifty (150) of Village, according to the plat thereof on file and of record in the office of the Register of Deeds for said Washington County, thence Southwesterly along the Northwesterly line of said Lot to the Southwesterly line of said Lot; thence Southeasterly along the Southwesterly line of said Lot to the North line of Lake Street; thence at right angles to said North line of Lake Street to the middle line of said street; thence Easterly along the center line of Lake Street to the West line of the East half of the Northeast quarter (1/4 of 1/4) of Section Twenty (20), Township Thirty (30) North, Range Twenty-one (21) West (being a westerly boundary line of the Village of Lake Street); thence North along the West line of said East half of Northeast quarter to a point intersected by the center line of Marshall Street; thence Northwesterly along the center line of Marshall Street to a point intersected by the extension Northwesterly of the Northwesterly line of said Lot 3 with said center line of Marshall Street; thence Southwesterly along said extended line to the point of beginning.

and that said territory is hereby made a part of the Village of Lake Street as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and with the Minnesota Municipal Commission and from and after its publication.
