

CHAPTER NO. 280

AN ORDINANCE TO ANNEX certain tracts of land to the City of Montevideo and declaring said tract to be an addition to and a part of the City of Montevideo,

WHEREAS, a petition has been filed with the City Council of the City of Montevideo by the owners in fee of the following described tracts of land lying and being in the County of Chippewa, State of Minnesota, to-wit:

A tract of land in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) Section Six (6), Township One Hundred Seventeen (117), Range Forty (40) West of the Fifth Principal Meridian described as Lots One through Fourteen (1 through 14) of Block One (1) of Anderson's North Side Addition.

praying that said tracts be annexed to and made a part of the City of Montevideo, and said petitioners having undertaken and agreed to accept and pay for any special assessments which may be levied against said tract of land for public improvements, and

WHEREAS, it appears that said tract of land abut upon the incorporated City of Montevideo, that said petitioners are the sole owners in fee thereof, that said tract of land is suitable for residential purposes and are so located as to be properly subject to annexation to the City of Montevideo and is suitable and adaptable to municipal purposes and municipal regulations, control and government.

NOW THEREFORE, the City of Montevideo does ordain as follows:

Section 1. That the certain tract of land lying and being in the County of Chippewa, State of Minnesota, described as follows, to-wit:

A tract of land in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) Section Six (6), Township One Hundred Seventeen (117), Range Forty (40) West of the Fifth Principal Meridian described as Lots One through Fourteen (1 through 14) of Block One (1) of Anderson's North Side Addition.

be and the same is hereby declared to be annexed to the City of Montevideo and that said tract of land is hereby declared to be an addition to the City of Montevideo and is hereby made a part of said City of Montevideo and of the residence district thereof as defined and described by the ordinances of said City.

Section 2. This Ordinance shall take effect and be in force from and after its publication according to the provisions of the City Charter.
