IN THE MATTER OF THE PETITION FOR DETACHMENT OF REAL  
ESTATE FROM THE CITY OF SLEEPY EYE, MINNESOTA UNDER  
LAWS 1959, CHAPTER 696, SECTION 6, SUBDIVISIONS 1 AND 3.

ORDER

The City of Sleepy Eye has, by resolution at a regular meeting of the City Council held May 3, 1960, petitioned for the detachment of certain property adjacent to the municipal boundary, unplatted, and occupied and used exclusively for agricultural purposes, hereinafter described, from the City of Sleepy Eye, Minnesota. An identical petition has also been received from all of the owners of the property affected.

The territory involved consists of:

The West half (1/2) of Government Lot One (1) in Section Thirty (30), Township one hundred ten (110), Range thirty-two (32), City of Sleepy Eye, Brown County, Minnesota.

The property is unplatted and is used and occupied exclusively for agricultural purposes. This detachment would not unreasonably affect the symmetry of the municipality. The land is not needed for reasonable anticipated future development. The petition is in proper legal form and sets forth the information required in Laws 1959, Chapter 696, Section 6, and upon all the files and records, the Commission being fully advised in the premises,

IT IS ORDERED: That the above described real property be and is hereby detached from the City of Sleepy Eye and made a part of the Town of Hens the same as if it had originally been a part thereof.
