ORDINANCE # 46 AN ORDINANCE TO EXTEND THE BOUNDARTES OF YOUNG AMERICA AND INCORPORATE ADDI-TIONAL TERRITORY THEREIN.

The Village Council of the Village of Young America, Minnesota, do ordain:

Section 1. - Village Boundary Extended: Pursuant to a petition dyly signed by Oscar E. Schrupp, and Agnes Schrupp, the owners of the land described as follows:

> Commencing ata point on the center line running North and South of Section 11, 'nownship 115 Range 26, said point being 14.80 chains North of the Post which stands in center of Section 11, 'nownship 115 Range 26; thence running North 89*10' West, 155.0 feet; thence South 0*50' West, 368.3 feet to center line of Carver and Glencoe Road; thence South 55*23' East, 186.5 feet along center line of said road to center section line running North 0*50' East through Section 11; thence along said Section line 472.3 feet to place of beginning, containing 1.5 acre of land; excepting that tract of land described as follows: Commencing at a point on the center line running North and South of Section 11, Township 115 Range 26, Saiden point being 14.80 chains North of a post which stands in center of Section 11, Township 115 Range 26; thence running North 89*10' West, 155 feet; thence South 0*50' West, 368.3 feet to center line of Carver and Glencoe road; thence South 55*23' East, 91 feet ten inches; thence North parallel to center line of said Section to a point 247½ feet South of the North line of the within described tract; thence East to a point on center line of said Section, 247½ feet South of the place of beginning; thence North on center line of said Section, 247½ feet to place of beginning, and,

Pursuant to a petition duly signed by William Raymond Patterson, the owner of the following described tract of land, situate in Carver County, Minn.,
