

AN ORDINANCE ENACTING THE CORPUScular LANDS OF THE CITY OF STAPLES  
AND APPROVING AND ADOPTING THE SAME.

The City Council of the City of Staples do enact as follows:

Section 1. Be it enacted by the Council of the City of Staples that all lands and buildings situated within the limits of the City of Staples, Todd County, Minnesota, and all property so described as follows,

That part of the Southernly quarter of the Township Section 13-32-13, of Section 1, Township 13-32-13 West, described as follows: commencing at the point on the west line of said quarter where the same intersects the south line of the State Highway Number 10, thence north along the south line of said quarter of said town 880 feet to the intersection of said highway Number 10, thence south 23 degrees 40 minutes east 314 feet along the west-of-way line of State Highway Number 10 to the place of beginning, thence south 88 degrees 56 minutes east 214 feet continuing along said highway right-of-way line; thence north 664 feet; thence north 88 degrees 00 minutes west 404 feet; thence south 684 foot to the place of beginning.

(containing 4.08 acres)

The corporate limit of the City of Staples shall be changed so as to include the above described lands within its said limits, and the same described lands shall hereafter be included within the corporate limits of said City of Staples and shall be a part of said City of Staples and shall be governed as other lands and territory in said City of Staples are now governed.

Section 2. The aforesaid lands and territory shall be annexed to the City of Staples, and this ordinance shall take effect and be in full force and effect from and after its passage, approved, and published.

Section 3. The City Clerk of the City of Staples is hereby directed to forward a certified copy of this ordinance to the County Auditor of Todd County, Minn., and to the Secretary of the State of Minnesota, and to the Commission on Municipal Consolidation & Annexations.

The above ordinance was passed at a regular meeting of the City Council of the City of Staples on this sixth day of May 1960.
