

AN ORDINANCE CHANGING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING CERTAIN UNINCORPORATED LANDS.

The City Council of the City of Staples do enact as follows:

Section 1. Pursuant to a petition duly signed by the owners of the following described property, and which property is suitable for municipal government and which property sits and is adjacent to the City of Staples, Todd County, Minnesota, and which property is described as follows, to-wit:

That part of the Southeast quarter of the Southeast quarter (SE¹/₄-SE¹/₄) of Section 1, Township 143 North, Range 14 West, described as follows: Beginning at the north end of the east line of said SE¹/₄-SE¹/₄ which is 100.00 feet; thence south 88 degrees 00 minutes east 100.00 feet; thence north 88 degrees 00 minutes east 100.00 feet; thence south 88 degrees 00 minutes east 100.00 feet; thence north 88 degrees 00 minutes west 100.00 feet; thence south 88 degrees 00 minutes east 100.00 feet; thence north 88 degrees 00 minutes west 100.00 feet; thence south 88 degrees 00 minutes east 100.00 feet to the place of beginning. (containing 3.03 acres)

The corporate limits of the City of Staples shall be changed so as to include the above described lands within its said limits, and the above described lands shall hereafter be included within the corporate limits of said City of Staples and shall be a part of said City of Staples and shall be governed as other lands and territory in said City of Staples are now governed.

Section 2. The aforesaid lands and territory shall be annexed to the City of Staples, and this ordinance shall take effect and be in full force and effect from and after its passage, approval, and publication.

Section 3. The City Clerk of the City of Staples is hereby directed to forward a certified copy of this ordinance to the County Auditor of Todd County, Minn., and to the Secretary of the State of Minnesota, and to the Commission on Municipal Consolidation & Annexation.

The above ordinance was passed at a regular meeting of the City Council of the City of Staples on this 26th day of May 1960.
