ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF MANKATO TO INCLUDE CERTAIN
UNPLATTED LAND NOT EXCEEDING TWO HUNDRED
ACRES, PURSUANT TO CHAPTER 696, LAWS OF
MINNESOTA, 1959 SESSION.

The City of Mankato, Minnesota does ordain:

Section 1.

A petition has been filed with the City Clerk of the City of Mankato, Minnesota by William B. Stevenson, as Assistant Commissioner of Administration in the name of and in behalf of the State of Minnesota, sole owner of the following described real estate to have such land included within the City of Mankato, Minnesota, to-wit:

56.56 acres of the North 48 acres of the West one-half of the Northeast Quarter of Section 19, Township 108 North, Range 26 West, except the North 25 foot thereof, and except that portion platted as Schourop's Third Highland Park Addition, containing 11 acres more or less.

Section 2.

The quantity of land embraced within the foregoing description is unplatte and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the southerly and westerly boundary of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census.

Section 3.

The City Council of Mankato, Minnesota hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tract and parcel of land is so conditioned as properly to be subjected to city government and is hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State and this ordinance takes effect 10 days after its passage and publication and the filing of certified copies, as herein described.
