

ORDINANCE NO. 125

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF NORTHFIELD TO INCLUDE CERTAIN UNPLATTED LAND

RECORDED IN STATE DEPARTMENT OF STATE JUL 15 1960

Section 1. A petition has been filed with the governing body of the City of Northfield, Minnesota, by the sole owner or all of the owners in number of the following described real estate to have such land included within the City of Northfield, Rice County, Minnesota:

The Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$) and the East One-half of the West One-half of the Southeast Quarter (E $\frac{1}{2}$ W $\frac{1}{2}$ SE $\frac{1}{4}$) and the Southwest Quarter of the Southeast Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$), all in Section Thirty-five (35), Township One Hundred Twelve (112), Range Twenty (20); except commencing at center of South line of the Southeast Quarter (SE $\frac{1}{4}$) of Section Thirty-five (35), Township One Hundred Twelve (112), Range Twenty (20), thence running eight (8) rods West; thence North forty (40) rods; thence East eight (8) rods; thence South on Center line of said quarter section to place of beginning.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is eighty-eight (88) acres.

Section 3. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Northfield, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 4. The corporate limits of the City are hereby extended to include the property described in Section 1 and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof.

Section 5. The City Recorder is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 6. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 5.
