



ORDINANCE NO. 321

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON TO INCLUDE CERTAIN PLATTED AND UNPLATTED LANDS.

The City Council of the City of Worthington Do Ordain:

Section 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number, of the following described real estate to have such land included within the City of Worthington, Minnesota:

Lots 5, 6, 7, and 8, Auditor's Plat of Block 8, Ludlow Acres, Section 27, Township 102, Range 40; and that part of the Southeast Quarter (SE $\frac{1}{4}$) of Section 27, Township 102, Range 40, described as follows, to-wit: Beginning at the southwest corner of said Lot 7, thence southeasterly on a prolongation of the line between Lots 7 and 8 of said Auditor's Plat, a distance of 150 feet; thence southwesterly a distance of 70 feet to a point, which point is 150 feet southeasterly from the southwest corner of said Lot 8, and being the point of beginning; thence northwesterly a distance of 150 feet to the southwest corner of said Lot 6, thence northeasterly along the southeasterly lines of said Lots 8, 7, 6, and 5, to the southeasterly corner of said Lot 5, thence in a southeasterly direction a distance of 150 feet to a point which is 280 feet northeasterly of the point of beginning; thence southwesterly a distance of 280 feet to the point of beginning; all in Nobles County, Minnesota.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is one and nine tenths (1.9) acres.

Section 3. A hearing was duly held by the City Council of the City of Worthington, Minnesota, on the proposed annexation after publication of the notice of hearing as required by the City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the city are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had been originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Corporation, the County Auditor, and the Secretary of State.

Section 7. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 6.
