ORDINANCE NO. 100

An Ordinance According Lot 9 and Part of
Lot 10, of East Shore Garden Lots, to
the Village of Muhlenudi,

THE VILLAGE COUNCIL OF THE VILLAGE OF MUHLENUDI DO ORDER AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of Lot 9, and that part of Lot 10 of East Shore Garden Lots sought to be annexed, in Washington County, Minnesota, containing less than one hundred acres, situated on a westerly side of the Village of Muhlenudi, requesting the annexation of said land to said village, said petition having been duly filed with the Clerk of said village; and it appearing that such annexation will be to the best interests of the village and of the territory affected, the village boundaries of the Village of Muhlenudi are hereby extended to include said land described by the following boundary lines:

Commencing at a point in the center line of Hallon Street intersected by the North line of Lot Nine (9) of East Shore Garden Lots, extended westerly to said center line; thence South along the center line of Hallon Street to the center line of Prospect Street (now known as Hickory Street); thence East along the center line of said Prospect Street (now known as Hickory Street) a distance of Two Hundred Fifty-five (255) feet; thence North on a line parallel to the East line of Hallon Street to a point One Hundred Seventy-three and 83/100 (173.83) feet North of the South line of Lot Ten (10) of East Shore Garden Lots; thence East on a line parallel to the North line of said Prospect Street (now known as Hickory Street) to the East line of Lot Ten (10) of East Shore Garden Lots; thence North along the East line of Lots Ten (10) and Nine (9) of East Shore Garden Lots to the Northeast corner of said Lot Nine (9); thence West along the North line of said Lot Nine (9) to the point of beginning.

and that said territory is hereby made a part of the Village of Muhlenudi as affectually as if the same had originally been a part of said village.

Section 2. This Ordinance shall take effect and be in force upon filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and with the Minnesota Municipal Commission and from and after its publication.
