## COMMENCE NO. 326

AN ORDINANCE EXTENDING THE COMPORATE LIMITS OF THE CITY OF WORTHINGTON TO INCLUDE CENTAIN PLATTED LAND.

The City Council of the City of Forthington Do Ordain:

Section 1. A potition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number, of the following described real estate to have such land included within the City of Worthington, Minnesota:

Lots 11, 12, and 13, of Auditor's Plat of Block 7, Ludlow Acres, Section 27, Township 102 North, Range 10 Nest, Nobles County, Minnesota.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is seven tenths (.7) acres.

Section 3. A hearing was duly held by the Gity Council of the Gity of Worthington, Minnesota, on the proposed annexation after publication of the notice of hearing required by the City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.
