

An Ordinance Amending Acts 5 and 6 of Hanson's Addition to Town of East Shore, to the Village of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO hereby AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of Lots Five (5) and Six (6) of Hanson's Addition to Town of East Shore, sought to be annexed, in Washington County, Minnesota, containing less than two hundred acres, abutting on a Westerly and Southerly side of the Village of Mahtomedi, requesting the annexation of said land to said Village, said petition having been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described by the following boundary lines:

Commencing at a point in the center line of Woodland Street (now known as Iris Street) intersected by the West line of Lot Six (6) of Hanson's Addition to Town of East Shore, produced Northerly to said center line; thence East along the center line of Woodland Street (now known as Iris Street) to the center line of Hallam Street; thence South along the center line of Hallam Street to the center line of Prospect Street (now known as Hickory Street); thence West along the center line of said Prospect Street (now known as Hickory Street) to a point intersected by said West line of said Lot Six (6) produced Southerly to said last mentioned center line; thence North along the West line of said Lot Six (6) to the point of beginning.

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and with the Minnesota Municipal Commission and from and after its publication.
