ORDINANCE CHANGING VILLAGE ELECTION DATE

WHEREAS, Minnesota Statutes, Section 205.07 authorizes the Council to designate the first Tuesday after the first Monday in November as the regular village election date.

AND WHEREAS, The Council believes that this change in election date should be made in this village,

NOW, THEREFORE, THE VILLAGE COUNCIL OF ALBANY, MINNESOTA, ORDAINS

SECTION 1. Commencing with the 1960 Village election, the regular village election of the Village of Albany, shall be held annually on the first Tuesday after the first Monday in November of each year.

SECTION 2. This ordinance shall take effect upon its passage and publication.

AFFIDAVIT OF PUBLICATION

being duly sworn, on oath says; that he is, and during all the time herein stated has been the publisher of the newspaper known as THE ALBANY ENTERPRISE and has full knowledge of the facts hereinafter stated; that for more than one year prior to the publication therein of
