ORDINANCE CHANGING VILLAGE ELECTION DATE

WHEREAS, Minnesota Statutes, Section 205.07 authorizes the Council to designate the first Tuesday after the first Monday in November as the regular village election date.

AND WHEREAS, The Council believes that this change in election date should be made in this village,

NOW, THEREFORE, THE VILLAGE COUNCIL OF ALBANY, MINNESOTA, ORDAINS

SECTION 1. Commencing with the 1960 Village election, the regular village election of the Village of Albany, shall be held annually on the first Tuesday after the first Monday in November of each year.

SECTION 2. This ordinance shall take effect upon its passage and publication.

AFFIDAVIT OF PUBLICATION

being duly sworn, on oath says; that he is, and during all the time herein stated has been the publisher of the newspaper known as THE ALBANY ENTERPRISE and has full knowledge of the facts hereinafter stated; that for more than one year prior to the publication therein of

hereinafter described, said newspaper was printed and published in the Village of Albany, in the County of Stearns, State of Minnesota, on Thursday of each week; that during all said time said newspaper has been printed in the English language from its known office of publication within the Village of Albany from which it purports to be issued as above stated and in newspaper format and in column and sheet form in space to at least 450 running inches of single column, two inches wide; has been issued each week from a known office established in said place of publication and employing skilled workmen and equipped with the necessary material for preparing and printing the same, and the presswork on that part of the newspaper devoted to local news of interest to community which it purports to serve has been done in its known office of publication; that during all said time in its makeup not less than twenty-five per cent of its news columns have been devoted to local news of interest to the community it purports to serve; that during all said time it has not wholly duplicated any other publication, and has not been entirely made up of patents, plate matter and advertisements; has been circulated in and near its said place of publication to the extent of at least two hundred and forty (240) copies regularly delivered to paying subscribers and has entry as second class matter in its local post office; and that there has been on file in the office of the County Auditor of Stearns County, Minnesota, the affidavit of a person having knowledge of the facts, showing the name and location of said newspaper and the existence of the conditions constituting its qualifications as a legal newspaper.
