## ORDINANCE NO. 317

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON TO INCLUDE CERTAIN PLATTED LAND.

The City Council of the City of Worthington Do Ordain:

Section 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number, of the following described real estate to have such land included within the City of Worthington, Minnesota:

Lot Eleven (11), Auditor's Plat of Block Eight (8), Ludlow Acres, Section 27, Township 102 North, Range 40 West, Nobles County, Minnesota.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described, is twenty-three one hundreths (.23) acres.

Section 3. A hearing was duly held by the City Council of the City of Worthington, Minnesota, on the proposed annexation after publication of the notice of hearing required by the City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the city are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had been originally a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Corporation, the County Auditor, and the Secretary of State.

Section 7. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 6.
