

ORDINANCE NO. OO-6

AN ORDINANCE AMENDING PROPERTY TO THE VILLAGE OF PRIOR LAKE, MINNESOTA

WHEREAS, Clifford M. Bischur and Kathryn H. Bischur, his wife, the owners of the following described property to-wit:

The East 57 rods of Government Lot 3, Section 35, Township 115, Range 22, excepting therefrom land and road easements contained in plat of Point Beautiful, Scott County, Minnesota, according to the plat thereof on file and of record in the Office of the Register of Deeds in and for Scott County, Minnesota, and also the East 57 rods of Government Lot 1, Section 2, Township 114, Range 22 lying North of Railroad right of way,

have petitioned the Village Council of the Village of Prior Lake, Minnesota, to have the above described land which lies outside the Village of Prior Lake, Minnesota, annexed to the Village of Prior Lake, Minnesota; and

WHEREAS, the Village Council deems it advisable and in the public interest that said property be so annexed, and

WHEREAS, the Village Council does hereby find and determine that annexation will be to the best interest of the Village, that the above described property abuts upon the Village of Prior Lake, is not included in any other municipality, is unplatated and contains of less than 200 acres, and is so conditioned as properly to be subjected to Municipal government,

NOW THEREFORE, the Village Council of the Village of Prior Lake, Minnesota, does ordain as follows:

SECTION 1.

That the following described property to-wit:

The East 57 rods of Government Lot 3, Section 35, Township 115, Range 22, excepting therefrom land and road easements contained in plat of Point Beautiful, Scott County, Minnesota, according to the plat thereof on file and of record in the Office of the Register of Deeds in and for Scott County, and also the East 57 rods of Government Lot 1, Section 2, Township 114, Range 22 lying North of Railroad right of way,

which lies outside the corporate limits of the Village of Prior Lake, Minnesota, be and the same is hereby annexed to the Village of Prior Lake, Minnesota, and said property is hereby declared to be an addition to said Village.

Upon the execution date of this Ordinance such property shall become a part of said Village as effectively as if it had been originally a part thereof.

SECTION 2.

This Ordinance shall take effect and be in force from and after its passage and publication and after filing as herein-after set forth. The Village Clerk is hereby directed to cause certified copies of this Ordinance to be recorded and filed in the Office of the Register of Deeds of Scott County, Minnesota, the Office of the County Auditor, Scott County, Minnesota, the Office of the Secretary of the Municipal Commission, State of Minnesota, and in the office of the Secretary of State of the State of Minnesota.
