

ORDINANCE NO. 1001

AN ORDINANCE Annexing to the City of Rochester, Minnesota Certain Lands in Section Twelve, Township 106 North, Range 14 West, Olmsted County, Minnesota.

WHEREAS, the City of Rochester, Minnesota is the owner of certain lands in Section 12, Township 106 North, Range 14 West, Olmsted County, Minnesota, more specifically described below, which lands abut upon the present territorial limits of the said City of Rochester and are now being used for public airport purposes, and

WHEREAS said lands are deemed to be suitably conditioned for municipal government,

NOW THEREFORE, the Common Council of the City of Rochester do ordain:

SECTION 1. The following described lands in Olmsted County Minnesota are hereby annexed, added to and made a part of the City of Rochester, Minnesota:

Beginning at the 1/16th corner on the west line of Section 12 in Township 106 North, Range 14 west of the Fifth Principal Meridian, in Olmsted County, Minnesota, which point is distance 1315.5 feet South of the Northwest corner of said Section 12, thence running East along the South line of 14th Street S. E. for a distance of 360.9 feet, thence running North along the East line of 4th Avenue S. E. for a distance of 623.3 feet to the South line of 13th Street S. E., thence running East along the South line of 13th Street S. E. for a distance of 2266.8 feet to the North-South quarter line of said section 12, thence running North along said quarter line for a distance of 692.2 feet to the North quarter corner of said Section, thence running East along the North line of said Section for a distance of 142.2 feet to the center line of the so-called "Pleasant Grove Road," thence running South 15 degrees and 20 minutes East for a distance of 5464.5 feet along the center line of said road to the South line of said Section 12 at a point which is distant 1587 feet East of the South quarter-corner thereof; thence running west along the South line of said Section for a distance of 3573.6 feet to the center line of the Chicago Great Western Railroad Right-of-Way, thence running along the center line of said railroad North 1 degree and 24 minutes West for a distance of 2425.7 feet, thence continuing on said center line in a Northwesterly direction on a 3 degree curve - central angle of 30 degrees and 1 minute left - for a distance of 1000.6 feet, thence continuing along said center line on tangent to said curve North 31 degrees and 35 minutes West for a distance of 575 feet more or less to the West line of said Section 12, thence running North along said West line for a distance of 80.5 feet to the place of beginning. Excluding therefrom the railroad right-of-way 50 feet in width along the westerly boundary. Comprising 323 acres more or less.

SECTION 2. The lands described in Section 1 are owned by the City of Rochester, abut upon the present territorial limits of the City of Rochester and are hereby determined to be suitably conditioned for municipal government.

SECTION 3. This Ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.
