

ORDINANCE EXPANDING THE CORPORATE LIMITS
OF THE CITY OF MANKATO TO INCLUDE CERTAIN
UNPLATTED LAND NOT EXCEDING TWO HUNDRED
ACRES, PURSUANT TO CHAPTER 686, LAWS OF
MINNESOTA, 1959 SECTION.

The City of Mankato, Minnesota does ordain:

Section 1.

A petition has been filed with the City Clerk of the City of Mankato, Minnesota by the Commissioner of Highways, in the name of and in behalf of the State of Minnesota, sole owner of the following described real estate to have such land included within the City of Mankato, Blue Earth County, Minnesota, to-wit:

All that part of the Southeast Quarter of the Southeast Quarter of Section 17, Township 108 North, Range 26 West, lying easterly of the westerly right of way line of Trunk Highway No. 22 as now located and established through said subdivision, together with all that part of the South 35 foot of the Northeast Quarter of the Southeast Quarter of said Section 17 lying within the right of way of said Trunk Highway.

Section 2.

The quantity of land embraced within the foregoing description is un-platted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the southwesterly and westerly boundary of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census.

Section 3.

The City Council of Mankato, Minnesota, hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tract and parcel of land is so conditioned as properly to be subjected to city government and is hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota, are hereby extended to include said property.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State and this ordinance takes effect 10 days after its passage and publication and the filing of certified copies, as herein described.
