THE COUNCIL OF THE CITY OF STILLMARTS TO OFFAIN AS FOLIATES:

SECTION 1. The following territory, consisting of unplatted land not exceeding two hundred (200) acros, abutting upon the City of Stillwater, Washington County, Minnesota, being so conditioned as properly to be subject to numbelpal government and not included in any other municipality, upon potition of all the exact in number, and in the best interests of the City of Stillwater and of said territory, is hereby declared to be annoted to the said City, to-wit:

The North Half of the Northeast (warter (N) of Net) of Section Thirty-one (31) and the North Half of the Northwest (warter (N) of Net) of Section Thirty-two (32) in Township Thirty (30), Range Twenty (20), excepting that part thereof lying East of the public read running Northeasterly and Southwesterly across said tract; also excepting that part of said tract described as follows: Commencing at the intersection of the South line of said tract with the West line of said public read; thence Northeasterly along said west line Three Hundred Sixty (360) feet to the point of the beginning for the tract of land hereby excepted; thence Northwesterly at right angles to said West line Two Hundred Fifteen (215) feet; thence Southeasterly at right engles to the last mentioned line Two Hundred Fifteen (216) feet, more or less, to said west line; thonce Southwesterly along said west line Two Hundred Forty (240) feet, thence Southeasterly at right engles to the last mentioned line Two Hundred Forty (240) feet, more or less, to said west line; thonce Southwesterly along said west line Two Hundred Forty (240) feet, more or less, to the point of beginning.

SECTION 2. The above described territory shall be incorporated in and become a part of the Second Ward of the City for election purposes.

SECTION 5. This ordinance shall be in full force and effect from and after its passage and publication, and the amnomation provided for herein shall be deemed final upon filing a copy hereof with the Minnesota Municipal Commission, the Washington County Auditor and the Secretary of State.
