

ORDINANCE NO. 527.

AN ORDINANCE AMENDING ORDINANCE NO. 520 WHICH IS AN ORDINANCE AMENDING SECTION 301 OF THE MUNICIPAL CODE OF THE CITY OF SOUTH ST. PAUL, MINNESOTA, BY EXPANDING THE CORPORATE LIMITS OF THE CITY OF SOUTH ST. PAUL TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEDING TWO HUNDRED (200) ACRES.

The City Council of the City of South Saint Paul does ordain:

SECTION I.

A petition has been filed with the governing body of the City of South Saint Paul, Minnesota, by the sole owner or all of the owners in number of the following described real estate to have such land included within the City of South St. Paul, Minnesota:

(32) The West 4.23 acres of the NW $\frac{1}{4}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 34, Township 28 North, Range 22 West, being more fully described as follows:  
Beginning at the Northwest corner of said SW $\frac{1}{4}$ SW $\frac{1}{4}$  of said Section 34, thence East 279 feet on the North Line of said SW $\frac{1}{4}$ SW $\frac{1}{4}$ , thence South 656.7 feet to the South Line of said NW $\frac{1}{4}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$ , thence West 279 feet to the West Line of said NW $\frac{1}{4}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$ , thence North 656.7 feet to the point of beginning

SECTION II.

The quantity of land embraced within the foregoing description, and bounded as described, is 4.23 acres.

SECTION III.

The City Council hereby determines (1) that the annexation will be to the best interests of the City of South St. Paul, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

SECTION IV.

Therefore, the City of South St. Paul, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of South St. Paul, Minnesota, as effectually as if it had originally been a part thereof.

SECTION V.

This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.

ORDINANCE NO. 516

AN ORDINANCE AMENDING CHAPTER 2100 BY ADDING THEREIN A SECTION TO BE DESIGNATED AS SECTION 2110 BEING AN ORDINANCE APPROPRIATING CERTAIN LAND TO THE CITY OF SOUTH SAINT PAUL AND DECLARING SAID LAND TO BE AN ADDITION TO SAID CITY.

The City Council of the City of South Saint Paul doth ordain:

SECTION I.

That Chapter 2100 of the Municipal Code is hereby amended by adding thereto Section 2110 which provides as follows:

SECTION 2110.01

That the following described real estate situated in the township of Inner Grove, County of Dakota, State of Minnesota, and abutting upon and contiguous to the incorporated City of South Saint Paul, Minnesota, to-wit:

The West 4.23 acres of the NW&SW& of Section 34, Township 28 North, Range 22 West, being more fully described as follows: Beginning at the Northwest corner of said SW&SW& of said Section 34, thence East 279 feet on the North Line of said SW&SW&, thence South 656.7 feet to the South Line of said NW&SE&SW&, thence West 279 feet to the West line of said NW&SE& SW&, thence North 656.7 feet to the point of beginning,

be and hereby is declared to be an addition to the City of South St. Paul and annexed to said City.

SECTION II.

This ordinance shall take effect and be in force from and after its passage, approval and publication.
