That said proposed amendment was duly submitted for adoption 3. or rejection of the electors of said City at the election held on the 8th day of November, 1960.

That from the Official Canvass of the votes cast at the said 4. election for and against aforesaid proposed amendment made in conformity with the law, that more than three-fifths of all electors voting at such election voted for the adoption of such proposed amendment.

That this certificate is made by me by virtue of the authority 5. vested in me as Mayor of the City of Faribault and in compliance with law, and to certify that aforesaid proposed amendment to the Charter of said City has been duly ratified and adopted as prescribed by the Constitution and Laws of said State. # CERTIFICATE OF AMENDMENT TO THE

CHARTER OF THE CITY OF

# FARIBAULT

I, Frank H. Duncan, Mayor of the City of Faribault in the

County of Rice and State of Minnesota, do hereby certify:

1. On the 29th day of September, 1960, the Board of Freeholders of said City duly submitted to me the following proposed amendment to the Charter of the City of Faribault:

AMENDMENT NO. 1

#### CHAPTER XVI. Section 114, (9).

To repeal therefrom said subparagraph (9), which reads as follows: -

"(9) HITCHING POSTS, ETC. To provide for and regulate the erection of hitching posts and rings for fastening horses, and to prohibit the same in such portions of the city as it shall see fit."

### CHAPTER XVI. Section 114, (34).

To repeal therefrom said subparagraph (34) which reads as follows: -

"(34) REGULATION OF STREET RAILROADS. To regulate street railways, their tracks and cars, to compel the owners of two or more such street railroads, using the same street, to use the same tracks and to equitably divide the cost of construction and maintenance thereof between them."

#### CHAPTER XVI. Section 114, (72).

To repeal therefrom said subparagraph (72) which reads as follows: -

"(72) LOCATION OF MARKET HOUSES. To establish and regulate the location of market houses, and to provide for the use thereof; to regulate the making and sale of bread and prescribe the weight and quality of the bread in the loaf and to provide for the seizure and forfeiture of bread baked contrary thereto."

# CHAPTER XVI. Section 114, (73).

To repeal therefrom said subparagraph (73) which reads as follows: -

"(73) HAY, WOOD, COAL ETC. To provide for and regulate the place and manner of weighing hay, straw, and of selling the same, and of measuring and selling fire wood, coal and lime."
