

**ORDINANCE NO. 414**  
(Special)

**An Ordinance Extending the Corporate Limits of the City of Willmar, Minnesota, to Include Certain Unplatted Land Not Exceeding Two Hundred Acres. (Described as part of NW $\frac{1}{4}$  of Sec. 23, Twp. 119, Range 35).**

BE IT ORDAINED BY THE CITY OF WILLMAR AS FOLLOWS:

SECTION 1. A Petition has been filed with the City Council of the City of Willmar, Minnesota, by the sole owners of all of the following described real estate to have such land included within the City of Willmar, Minnesota, to-wit:

All that part of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Twenty Three (23), Township One Hundred Nineteen (119) North Range Thirty Five (35), West, described by metes and bounds as follows: Commencing at a point on the North line of said Section Twenty Three (23), Six Hundred Sixty (660) feet West of the Northeast (NE) corner of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Twenty Three (23), of said Township and Range thence running South and parallel to the East line of the Northwest Quarter (NW $\frac{1}{4}$ ) of said Section Twenty Three (23) a distance of Six Hundred Fifty Five (655) feet, thence East and parallel with the North line of said Northwest Quarter (NW $\frac{1}{4}$ ), a distance of Six Hundred Sixty (660) feet to a point on the East line of said Northwest Quarter (NW $\frac{1}{4}$ ); thence South on and along said East line of said Northwest Quarter (NW $\frac{1}{4}$ ) to the center of said Section Twenty Three (23); thence West on and along the East-West Quarter line of said Section Twenty Three (23), a distance of Eight Hundred Thirty One (831) feet, more or less to the East bank of County Ditch No. 23; thence Northwesterly on and along said East bank of Ditch to a point which is Seven Hundred Sixty (760) feet South of the North line of said Section Twenty Three (23), and One Thousand Three Hundred Forty One (1,341) feet, more or less, West of the East line of said Northwest Quarter (NW $\frac{1}{4}$ ); thence running East and parallel to the North line of said Northwest Quarter (NW $\frac{1}{4}$ ) of said Section a distance of Six Hundred Thirty One (631) feet, more or less, thence running North and parallel to the East line of the Northwest Quarter (NW $\frac{1}{4}$ ) of said Section a distance of Seven Hundred Sixty (760) feet to the North line of said Section Twenty Three (23); thence running East on and along the said North line of said Section Twenty Three (23) a distance of Fifty (50) feet to the place of beginning, said tract containing 48.9 acres, more or less.

SECTION 2. The quantity of land embraced within the foregoing description, and bounded as described, is 48.9 acres.

SECTION 3. The City Council hereby determines:

1) That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected.

2) That the territory described herein abuts upon the City and is so conditioned as properly to be subject to City Government.

SECTION 4. Therefore the City of Willmar, Minnesota, hereby ordains and declares that the property hereinbefore described be, and the same is hereby, annexed to, and included in the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof; said area is hereby determined to be, and zoned as, Industrial Park District.

SECTION 5. This Ordinance shall be final and shall take effect and be in full force from and after filing certified copies hereof with the Minnesota Municipal Commission, The County Auditor of the County of Kandiyohi, Minnesota, and the Secretary of State of Minnesota, and from and after its passage and publication.

An Ordinance Entending the Corporate Limits of the City of Willmar, Minnesota, to include Certain Unimproved Land Not Exceeding Two Acres Located and Described as part of the NW 1/4 of Sec. 23, Twp. 12, Range 53.

BE IT ORDAINED BY THE CITY OF WILLMAR AS FOLLOWS:

SECTION 1. A Petition has been filed with the City Council of the City of Willmar, Minnesota, by the sole owners of all of the following described real estate to have such land included within the City of Willmar, Minnesota:

All that part of the Northwest Quarter (NW 1/4) of Section Twenty Three (23), Township One Hundred Nineteen (119) North, Range Fifty Five (55) West, described by metes and bounds, as follows: Commencing at a point on the North line of said Section Twenty Three (23), Six Hundred Sixty (660) feet West of the Northeast (NE) corner of the Northwest Quarter (NW 1/4) of Section Twenty Three (23), of said Township and Range thence southerly South and parallel to the East line of the Northwest Quarter (NW 1/4) of said Section Twenty Three (23) a distance of Six Hundred Fifty Five (655) feet; thence East and parallel with the North line of said Northwest Quarter (NW 1/4), a distance of Six Hundred Sixty (660) feet to a point on the East line of said Northwest Quarter (NW 1/4); thence South on and along said East line of said Northwest Quarter (NW 1/4) to the center of said Section Twenty Three (23); thence West on and along the East-West Quarter line of said Section Twenty Three (23), a distance of Eight Hundred Thirty One (831) feet, more or less to the East bank of County Ditch No. 33; thence Northwest on and along said East bank of Ditch to a point which is Seven Hundred Sixty (760) feet South of the North line of said Section Twenty Three (23), and One Thousand Three Hundred Forty One (1,341) feet, more or less, West of the East line of said Northwest Quarter (NW 1/4); thence running East and parallel to the North line of said Northwest Quarter (NW 1/4) of said Section a distance of Six Hundred Thirty One (631) feet, more or less, thence running North and parallel to the East line of the Northwest Quarter (NW 1/4) of said Section a distance of Seven Hundred Sixty (760) feet to the North line of said Section Twenty Three (23); thence running East on and along the said North line of said Section Twenty Three (23) a distance of Fifty (50) feet to the place of beginning, said tract containing 48.9 acres, more or less.
