ORDINANCE NO. 414 (Special)

An Ordinance Extending the Corporate Limits of the City of Willmar, Minnesota, to Include Certain Unplatted Land Not Exceeding Two Hundred Acres. (Described as part of NW1/4 of Sec. 23, Twp. 119, Range 35).

BE IT ORDAINED BY THE CITY OF WILLMAR AS FOLLOWS:

SECTION 1. A Petition has been filed with the City Council of the City of Willmar, Minnesota, by the sole owners of all ot the following described real estate to have such land included within the City of Willmar, Minnesota, to-wit:

Therefore the City of Willmar, Minnesota, hereby ordains and declares that the property hereinbefore described be, and the same is hereby, annexed to, and included in the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof; said area is hereby determined to be, and zoned as, Industrial Park District.
