

ORDINANCE NO. 320

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON, TO INCLUDE CERTAIN PLATTED LAND.

The City Council of the City of Worthington Do Ordain:

Section 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number, of the following described real estate to have such land included within the City of Worthington, Minnesota:

Lots One (1) and Two (2), Block Eleven (11), Auditor's Plat of Block Eleven (11), Ludlow Acres, in Section 26, Township 102, Range 40, Nobles County, Minnesota.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is forty-seven hundredths (.47) acres.

Section 3. A hearing was duly held by the City Council of the City of Worthington, Minnesota, on the proposed annexation after publication of the notice of hearing required by the City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein, abuts upon the city and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the city are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the city as effectually as if it had been originally a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Corporation, the Secretary of State, and the County Auditor.

Section 7. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 6.
