## ORDINANCE NO. 86

### An Ordinance Extending the Corporate Limits of the Village of Gibbon to Include Certain Platted Land.

SECTION 1. A petition has been filed with the governing body of the Village of Gibbon, Minnesota, by all of the owners of the following described real estate to have such land included within the Village of Gibbon, Minnesota:

Beginning at a point on the South right-of-way line of a public road 33 feet South and 203.7 feet East of the Northwest corner of Section 11, Township 112, Range 31, West, Thence East on said right-of-way line and also parallel with the North line of Section 11, a distance of 600 feet, thence running South on a line parallel with the West line of Section 11, a distance of 150 feet, thence running West on a line parallel with the North line of Section 11, a distance of 600 feet, there intersecting the East line of a cemetery, thence running North along the East line of the cemetery and also parallel to the West line of Section 11, a distance of 150 feet to the given point of beginning, and there terminating, containing 12 lots and being 2.07 acres, more or less, situate in the County of Sibley, State of Minnesota.

SECTION 2. The quantity of land embraced within the foregoing description, and bounded as described, is 2.07 acres.

SECTION 3. The village council hereby determines (1) that the annexation will be to the best interests of the Village of Gibbon, Minnesota, and of the territory affected; (2) that the territory described herein abuts the village and is so conditioned as properly to be subjected to village government.

SECTION 4. The corporate limits of the village are hereby extended to include the property described in Section 1 and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof.

SECTION 5. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

SECTION 6. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 5.
