ORDINANCE # 91
AN ORDINANCE EXTENDING THE CORPORATE
LIMITS OF THE VILLAGE OF NORWOOD TO
INCLUDE CERTAIN UNPLATTED LAND NOT
EXCEEDING 200 ACRES.

Section 1. = A petition has been filed with the governing body of the Village of Norwood, Minnesota, by Jacob Bentz and *Hildegard Bentz*, husband and wife, the sole owners of the following described real estate to have such lands included within the Village of Norwood, Minnesota:

Commencing at a point which point is 33 feet South, thence $3\frac{1}{2}$ 2.85 feet East of the Southwest corner of the Northwest Quarter of the Southwest Quarter of Section 14, Township 115 Range 26; thence running South 65 feet; thence East 75 feet; thence North 65 feet; thence West 75 feet to the place of beginning, containing .112 acre, more or less.

Situated in Lot 1 of Section 14, Township 115 Range 26.

Section 2. = The quantity of land embraced within the foregoing description, and bounded as described, is .112 acre.

Section 3. = The Village Council hereby determines (1) that the annexation will be to the best interest of the Village of Norwood, Minnesota and of the territory affected. (2) That the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village Government.

Section 4. = Therefore, the Village of Norwood, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to and included in the Village of Norwood, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. = This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and from and after its passage and publication.
