




KNOW ALL MEN BY THESE PRESENTS, THAT I, WALTER F. MONDALE, ATTORNEY GENERAL OF THE STATE OF MINNESOTA, BY VIRTUE OF THE AUTHORITY VESTED IN ME BY STATUTE, AND PARTICULARLY BY AUTHORITY OF MINNESOTA STATUTES 1957, SECTION 8.02, DO HEREBY CONSTITUTE AND APPOINT:

RALPH W. PETERSON

OF ST. PAUL, MINNESOTA, AS SPECIAL ASSISTANT ATTORNEY GENERAL IN THE DEPARTMENT OF TAXATION FOR THE PERIOD COMMENCING DECEMBER 14, 1960, AND TO SERVE AT THE PLEASURE OF THE ATTORNEY GENERAL, OR UNTIL THIS COMMISSION SHALL BE REVOKED OR OTHERWISE TERMINATED IN ACCORDANCE WITH LAW; AND I HEREBY FIX THE COMPENSATION OF SAID RALPH W. PETERSON AS SUCH SPECIAL ASSISTANT ATTORNEY GENERAL AT THE SUM OF TEN THOUSAND FIVE HUNDRED DOLLARS (\$10,500.00) PER YEAR, TO BE PAID FROM THE APPROPRIATION MADE FOR THE DEPARTMENT OF TAXATION.
