PAUL, MINNESOTA, AS SPECIAL ASSISTANT ATTORNEY GENERAL IN THE DEPARTMENT OF TAXATION FOR THE PERIOD COMMENCING DECEMBER 14, 1960, AND TO SERVE AT THE PLEASURE OF THE ATTORNEY GENERAL, OR UNTIL THIS COMMISSION SHALL BE REVOKED OR OTHERWISE TERMINATED IN ACCORDANCE WITH LAW; AND I HEREBY FIX THE COMPENSATION OF SAID FRED C. NORTON AS SUCH SPECIAL ASSISTANT ATTORNEY GENERAL AT THE SUM OF TEN THOUSAND FIVE HUNDRED DOLLARS (\$10,500.00) PER YEAR, TO BE PAID FROM THE APPROPRIATION MADE FOR THE DEPARTMENT OF TAXATION.
