Section 14, as amended, of the Home Rule Charter of the City of Robbinsdale is hereby amended to read as follows:

Section 14. Salary of Elected Officers. The Mayor and each Alderman shall receive a salary, the amount of which shall be prescribed by ordinance or resolution, but the salary of the Mayor shall not exceed ONE HUNDRED (\$100.00) DOLLARS per month, and the salary of each Alderman shall not exceed SEVENTY-FIVE (\$75.00) DOLLARS per month.
