

ORDINANCE NO. 219

AN ORDINANCE ANNEXING TO THE VILLAGE OF ST. PAUL PARK,
CERTAIN PROPERTY SITUATED IN SECTION 18, TOWNSHIP 27,
RANGE 21, WASHINGTON COUNTY, MINNESOTA.

WHEREAS, Bergor Leonard Tvotne, also known as Leonard B. Tvotne, and Dorothy E. Tvotne, husband and wife, B. & B. Honor, Inc., a Minnesota corporation, Marvin H. Anderson Construction Co., a Minnesota corporation and Jerome G. Harkins, and Carson A. Harkins, husband and wife, who are the owners of the following tract of land situated in the County of Washington, State of Minnesota, described as follows, to wit:

Commencing at the Northwest Corner of the Northeast Quarter of the Northwest Quarter ($\text{NE} \frac{1}{4}$ of $\text{NW} \frac{1}{4}$) of Section Eighteen (18), Township Twenty-seven (27), Range Twenty-one (21); thence east along the north line of said section 729 feet to a point, thence south parallel with the west line of said section a distance of 877 feet to a point; thence west parallel with the north line of said section 729 feet; thence north along the west line of said section 877 feet to the point of beginning,

have petitioned the Village Council of the Village of St. Paul Park to annex the above described property to said Village of St. Paul Park, Washington County, Minnesota, and

WHEREAS, all of said land abuts on the corporate limits of the Village of St. Paul Park, and

WHEREAS, all of said land is not now included in any other municipality; and,

WHEREAS, all of said land is unplatteed and does not exceed 200 acres; and,

NOW THEREFORE, be it ordained by the Village Council of the Village of St. Paul Park, Washington County, Minnesota, as follows:

1. That the Village Council of the Village of St. Paul Park does deem the following described property to be properly conditioned as properly to be subjected to municipal government and deems it to the best interests of the Village of St. Paul Park and of the property hereinafter described that said property be annexed to the Village of St. Paul Park, Washington County, Minnesota.

2. That the following described property situated in the County of Washington, State of Minnesota is hereby annexed to the Village of St. Paul Park, Washington County, Minnesota;

commencing at the Northwest corner of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section Eighteen (18), Township Twenty-seven (27), Range Twenty-one (21); thence east along the north line of said section 729 feet to a point; thence south parallel with the west line of said section a distance of 877 feet to a point; thence west parallel with the north line of said section 729 feet; thence north along the west line of said section 877 feet to the point of beginning.

3. This ordinance shall be in force and effect from and after its passage and publication, and the Village Clerk is hereby directed to file a certified copy of this ordinance with the Auditor of the County of Washington, Minnesota, the Secretary of State, State of Minnesota and the Commission created pursuant to laws of the 1959 State of Minnesota, Chapter 686, Section 1.
