

I, P. D. Gamroth, Clerk of the Village of Foley, Benton County, Minn., do hereby certify that the following is a correct copy of a portion of the minutes of the Village Council of said Village of Foley, held on the 1st day of June, A. D. 1915, annexing the following described tracts of land into the Village of Foley, not included in previous annexation to same:

"On motion of Councilman Fouquette, seconded by Clerk Gamroth, and carried, the following tracts of land were annexed to the Village of Foley, Benton County, Minnesota."

(1) A tract of land situate in the NW¹/₄ of Section ³⁵~~26~~, Twp. 37 N. Rge. 29 W. described as follows, to-wit:

Beginning at a point thirty-three (33) feet west of the quarter section corner between sections 35 and 26; thence south along the west line of the County road three hundred sixty (360) feet; thence east thirty-three (33) feet to the center line of said road; thence north along the said center line three hundred sixty (360) feet to the quarter section corner, before mentioned; thence west thirty-three (33) feet to place of beginning.

(2) A tract of land situate in the SW¹/₄ of section twenty-six (26) Twp. thirty-seven (37) north, Rge. twenty-nine (29) west, described as follows, to-wit:

Beginning at the quarter section corner between sections 35 and 26 of Range and Township aforesaid; thence north one hundred four and one half (104 $\frac{1}{2}$) feet; thence west and parallel with the south line of said section 26, thirty-three (33) feet to the west line of the county road; thence south along the west line of said county road one hundred four and one half (104 $\frac{1}{2}$) feet to the south line of section 26; thence east along said south line thirty three (33) feet to place of beginning.

(3) A tract of land situate in the SW¹/₄ of section twenty-six (26) Township thirty-seven (37) north, Range twenty-nine (29) west, described as follows, to-wit:

Beginning at a point on the quarter section line in said section twenty-six (26), three hundred thirteen and one half (313 $\frac{1}{2}$) feet north of the quarter section corner between sections 26 and 35; thence west and parallel with the south line of said section twenty-six (26) two hundred forty-two feet (242) feet; thence north and parallel with the said quarter section line in section twenty-six (26) thirty-three (33) feet; thence east and parallel with the said south line of section twenty-six (26) two hundred forty-two feet (242) feet to the quarter section line; thence south along the quarter section line thirty-three (33) feet to place of beginning.

(4) A tract of land situate in the SW¹/₄ of section twenty-six (26) Township thirty-seven (37) north, range twenty-nine (29) West, described as follows, to-wit:


Beginning at a point on the quarter section line in said section twenty-six (26), three hundred forty-six and one half (346 $\frac{1}{2}$) feet north of the quarter section corner between sections 26 and 35; thence north along said quarter section line, four hundred thirty-three and one half (433 $\frac{1}{2}$) feet; thence west and parallel with the south line of said section twenty-six (26), thirty-three (33) feet to the west line of the county road; thence south along the said west line of said county road, four hundred thirty-three and one half (433 $\frac{1}{2}$) feet; thence east and parallel with the south line of said section twenty-six (26), thirty-three (33) feet to place of beginning.

(5) - A tract of land situate in the SW $\frac{1}{4}$ of section twenty-six (26), Township thirty-seven (37) North, Range twenty-nine (29) West, described as follows, to-wit:

Beginning at a point on the west line of the county road, thirty-three (33) feet west and four hundred fifty-one (451) feet north of the quarter section corner between sections 26 and 35; thence west and parallel with the south section line of section twenty-six (26), two hundred nine (209) feet; thence north twenty nine (29) feet; thence east and parallel with the said south line of section twenty-six (26), two hundred nine (209) feet to the west line of said county road; thence south along the said west line of said county road, twenty-nine (29) feet to place of beginning.

(6) - That parcel of land in the village of Foley known as Fourth Avenue, described as follows, to-wit:

Beginning at a point where the north line of Martin Street intersects the east line of Fourth Avenue extended from the south, both streets being in Foley's First Addition to the Village of Foley, Benton County, Minnesota; Thence north along the west line of Hall's Third Addition to the Village of Foley, Benton County, Minnesota, twelve hundred sixty-one (1261) feet and four (4) inches to the south line of the state road; said point being the east line of the county road from the south; thence south along the said east line of the county road one hundred sixty (160) feet to the east line of Hall's Second Addition to the Village of Foley, Benton County, Minn.; thence south along the said east line of Hall's Second Addition, eleven hundred fifty-one (1151) feet to the north line of Martin Street of Foley's First Addition to the Village of Foley, Benton County, Minnesota, at its intersection with the west line of Fourth Avenue, same Addition, extended; thence east along the north line of said Martin Street eighty (80) feet to place of beginning.
