RESOLUTION.

Albert Pannek of the town of Avon and others of the Town of Avon, of the County of Stearns and State of Minnesota, having presented a petition praying for the incorporation of the Village of St. Anna in the County of Stearns and State of Minnesota, said petition appearing regular and signed by twenty-five electors within the territory to be incorporated, and a census having previously been taken of the residents therein, within eight weeks showing there being over two hundred residents therein, the following resolution was adopted by the County Board of Stearns County on the 14th day of September, A.D. 1915.

Resolved that the prayers of the petitioners be granted and that Saturday the 9th day of October 1915 A.D. between the hours of 9 o'clock A.M. and 5 o'clock P.M. at the Hall of Stanis Dobis building and in the second story of said building, which said building is located on lot 5 of the original plat of St. Anna, in said County of Stearns and State of Minnesota, a place within the limits of the proposed Village, be named and hereby is named as a time and place when and where the electors within the territory of said proposed Village of St. Anna will vote for or against such incorporation; that the following named electors, residents of said proposed village be and the same are hereby appointed to preside and act as inspectors at and over said election to-wit: Stanis Dobis, Frank Dobis and Simon Henneck. The West half of the Northwest quarter, the West half of Southwest Quarter, the Southeast quarter of Southwest quarter and the Southwest quarter of the Southeast quarter all in Section 4; and all of Section 5; the Northeast quarter and the ^{1/4 of the NW 1/4 of the} North half of the Southeast quarter of Section 6; Government Lot 1 of Section 8; the Northwest quarter and the West half of the Northeast quarter and the Northeast quarter of the Southwest quarter and the Southeast quarter of Section 9, all in Township 125 North of Range 30 West; also the Southeast quarter and the East half of the Southwest quarter and the Southeast quarter of Northwest quarter of Section 32, and the West half of Southwest quarter and the Southeast quarter of Southwest quarter of Section 33; all in Township 126 North of Range 30 West; and the territory hereinbefore described includes such lands heretofore surveyed and platted and known as "St. Anna" as on file and of record in the office of the Register of Deeds in and for said Stearns county, Minnesota.
