AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

The Common Council of the City of Marshall do ordain as follows:

Section 1. A petition has been filed with the Common Council of the City of Marshall, Minnesota by the sole owners of the following described real estate in the County of Lyon, State of Minnesota, to have such land included within the City of Marshall, Minnesota:

Beginning at the northwest corner of Section Ten (10), Township One Hundred Eleven (111) North, of Range Forty-one (41), West of the Fifth Principal Meridian; thence east thirty-three (33) feet; thence south and parallel to the west line of said Section Ten (10) to the extension of the south and east line of E Street of the City of Marshall; thence in a southwesterly direction along said extension of the south and east line of said E Street to the west line of said Section Ten (10); thence north along said west line of said Section Ten (10) to the point of beginning;

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is .09 acres, more or less.

Section 3. The Common Council hereby determines (1) that the annexation will be to the best interests of the City of Marshall, Minnesota and of the territory affected; and (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 5. Therefore, the City of Marshall, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of Marshall, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
