AH ORDINANCE ANNEXING CERTAL: LAND TO THE CITY OF HARDHALL, MICHESOTA

The Common Council of the City of Harchall do ordain as follows:

Section 1. The real estate hereinafter described and abutting upon the corporate limits of the City of Marshall is hereby emerged to said City.

Section 2. Said real estate so amered in located in the County of Lyon, State of Winacota, and is described as follows, to-wit:
