ORDINANCE NO. 176

AN ORDINANCE ANNEXING TO THE CITY OF EAST GRAND FORKS THE SOUTH 40 FEET OF THE NE $\frac{1}{4}$ OF SECTION 35, TOWNSHIP 152 NORTH, RANGE 50 WEST OF THE FIFTH PRINCIPAL MERIDIAN, POLK COUNTY, MINNESOTA.

The City Council of the City of East Grand Forks do ordain as follows:

Section 1. The City of East Grand Forks is the owner of the following described land situated in the County of Polk and State of Minnesota, to-wit: The South Forty (40) feet of the Northeast Quarter (NE $\frac{1}{4}$) of Section Thirty-five (35), Township One Hundred Fifty-two (152) North of Range Fifty (50), West of the 5th Principal Meridian.

Section 2. That the quantity of land embraced within the foregoing description is 2.42 acres.

Section 3. The City Council hereby determines:

(1) That the annexation of said tract of land will be to the best interests of the City of East Grand Forks, Minnesota, and the tract affected;

(2) That the tract of land described herein abuts upon the City of East Grand Forks, and is suitably conditioned for municipal government.

Section 4. The corporate limits of the City of East Grand Forks are hereby extended to include the property described in Section 1, and the same is hereby annexed to and included in the City as effectually as if it had originally been a part thereof.

Section 5. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 6. This ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 5.

It was moved by Alderman Paschka, and seconded by Alderman Ferguson, that the Ordinance be passed, and given the number 176.
