ORDINANCE AMENDING THE CORPORATE LIMITS
OF THE CITY OF MANKATO TO INCLUDE CERTAIN
UNPLATTED LAND NOT EXCLUDING TWO HUNDRED
ACRES, PURSUANT TO CHAPTER 606, LAW OF
MINNESOTA, 1939 SESSION.

The City of Mankato, Minnesota doth ordain:

Section 1.

A petition has been filed with the City Clerk of the City of Mankato, Minnesota by William E. Stevenson, as Commissioner of Administration in the name of and in behalf of the State of Minnesota, sole owner of the following described real estate to have such land included within the City of Mankato, Blue Earth County, Minnesota, to-wit:

The South 30 acres of the $\frac{1}{4}$ of the NW, Section 19, Township 100 North, Range 26 West, and

That part of the northwest quarter of the southeast quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) Section 19, Township 100 North, Range 26 West, described as follows: Beginning at a point 30 feet west of the northeast corner of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of said Section 19, thence south 63 rods; thence West 77 rods 11 $\frac{1}{2}$ foot to the West line of the said Southeast Quarter of said Section 19; thence North 23 rods; thence East 16 rods; thence North 40 rods; thence East 61 rods 11 $\frac{1}{2}$ foot to the point of beginning.

Section 2.

The quantity of land embraced within the foregoing description is unplattoned and doth not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the southerly boundary of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census.

Section 3.

The City Council of Mankato, Minnesota hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tract and parcel of land is so constituted as properly to be subjected to city government and is hereby annexed to and declared to be an addition to the City of Mankato, as affectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State and this ordinance takes effect 10 days after its passage and publication and upon the filing of certified copies, as herein described.


