ORDINANCE NO. 249

AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF MARSHALL, MINNESOTA

The Common Council of the City of Marshall do ordain as follows:

Section 1. The real estate hereinafter described and abutting upon the corporate limits of the City of Marshall is hereby annexed to said City.

Section 2. Said real estate so annexed is located in the County of Lyon, State of Minnesota, and is described as follows, to-wit:

Beginning at the northeast corner of Gray's 2nd Addition to the City of Marshall, Minnesota, thence running east along the south line of DeSchepper Street a distance of 110 feet; thence running south and parallel with the east line of Lawrence Street a distance of 136 feet; thence running east and parallel with the south line of DeSchepper Street a distance of 75 feet; thence in a southeasterly direction on a curve of 300 feet radius a distance of 471.24 feet to a point 436 feet south of the south line of DeSchepper Street; thence south and parallel with the east line of Lawrence Street a distance of 114 feet; thence running west and parallel with the south line of DeSchepper Street a distance of 115 feet; thence in a southwesterly direction angle left 13 degrees, 10 minutes with last line a distance of 67.8 feet; thence in a southwesterly direction angle left 7 degrees, 53 minutes with last line a distance of 368.8 feet; thence in a northerly direction on a curve of 152.75 feet radius and a central angle of 36 degrees, 15 minutes a distance of 91.5 feet; thence north on a prolongation of the west side of Lawrence Street a distance of 16.8 feet to the southeast corner of Lot 14 of Block 2 of Gray's 2nd Addition, thence east a distance of 66 feet; thence north along the east side of Lawrence Street a distance of 597.2 feet to the point of beginning.

Section 3. This ordinance shall take effect from and after its adoption and publication.
