ORDINANCE NO. 107

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE
INCORPORATED LIMITS OF THE CITY OF WACONIA

WHEREAS, a certain petition, dated the 14th day of December, 1960, and requesting annexation to the City of Waconia of those certain lands more particularly described below, was duly presented to the council on the 19th day of December, 1960, pursuant to Minnesota Statutes Section 414.03, Subd. 7; and

WHEREAS, the council finds that said petition was signed by all of the owners of said lands:

THE COMMON COUNCIL OF THE CITY OF WACONIA, CARVER COUNTY,
MINNESOTA, ORDAINS:

Section 1. Declaration. It is hereby determined that the territory described below abuts upon the present corporate limits of the City of Waconia; that said lands do not exceed 200 acres in area; that said lands are not now included in any other municipality; that said lands are conditioned as properly to be subjected to municipal government; and that annexation of said lands would be to the best interests of the City of Waconia and of said lands.

Section 2. Territory Annexed. The corporate limits of the City of Waconia are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

That part of the South Half (S $\frac{1}{2}$) of the North Half (N $\frac{1}{2}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section 23, Township 116, Range 25, lying between the Southerly extension of the Westerly right-of-way line of Vine Street and the Southerly extension of the Westerly right-of-way line of Maple Street, as said streets are now laid out in the City of Waconia.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State, and the Auditor of Carver County.

Section 4. Effective Date of Annexation. Annexation shall be deemed final upon the filing of certified copies of this ordinance as directed in Section 3 above.
