

ORDINANCE NUMBER 146

AN ORDINANCE ANNEXING CERTAIN DESCRIBED PROPERTY TO THE VILLAGE
OF FOREST LAKE, MINNESOTA

The Village Council of the Village of Forest Lake, County of
Washington, State of Minnesota ordains as follows:

WHEREAS a petition has been filed with the Village Council of the
Village of Forest Lake by the sole owner of the property
hereinafter described for inclusion of said property with-
in the Village limits, and

WHEREAS said described property is unplatted and does not exceed
200 acres in area, and

WHEREAS the Village Council has determined that the proposed
annexation will be to the best interests of the Village
and of the territory affected and that the property des-
cribed abuts upon the Village limits and is so conditioned
as property to be subject to Village government.

NOW THEREFORE:

1. The Corporate limits of the Village are hereby extended
to include the following described property and the
same is hereby annexed and included in the Village
limits as effectually as if it had originally been a
part thereof.

All that part lying and being in the North-
west corner of the Southeast Quarter of the
Northeast Quarter (SE $\frac{1}{4}$ of NE $\frac{1}{4}$) of Section
Seventeen (17), Township Thirty-two (32),
North, Range Twenty-one (21) West, Washington
County, Minnesota, and more particularly des-
cribed as follows, to-wit: Beginning at a
point on the north line of said Southeast
Quarter of Northeast Quarter (SE $\frac{1}{4}$ of NE $\frac{1}{4}$),
and on the easterly edge of the US Highway
No. 61, said point being approximately One
Hundred Sixty-seven (167) feet east of the
Northwest corner of said Southeast Quarter
of Northeast Quarter (SE $\frac{1}{4}$ of NE $\frac{1}{4}$). Thence
east along a north line One Hundred Ninety
(190) ft; thence South One Hundred Thirty-
two (132) ft; thence West One Hundred Ninety
(190) feet to the easterly edge of said U. S.
Highway No. 61; thence North skirting U. S.
Highway No. 61 for One Hundred Thirty-two
(132) feet to the point of beginning. Accord-
ing to the United States Government Survey
thereof.

Except South Thirty (30) feet thereof.
