ORDINANCE NO. 343
AN ORDINANCE EXTENDING THE CORPORATE
LIMITS OF THE CITY OF WHITE BEAR LAKE TO
INCLUDE CERTAIN LAND COMPLETELY SUR-
ROUNDED BY LAND WITHIN THE MUNICIPAL LIMIT

The City Council of the City of White Bear Lake does ordain as follows:

I.

On the 25th day of October, 1960, Resolution No. 526 was adopted by the City of White Bear Lake and on December 13, 1960 Resolution No. 534 was adopted by the City of White Bear Lake stating its intention to annex the following described real estate and fixing a time and place for hearing:

Port of NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 36, Township 30,
Range 22, not included in Golf View Heights No. 1

Registered Land Survey No. 67, Subject to Public
Easements; Tract GGG

Registered Land Survey No. 67, Subject to Public
Easements; Tract HHH,

II.

On the 21st day of March, 1961, which was at least ten (10) days after all of the owners and occupants of the land to be annexed were served in the manner provided for the service of a summons in a civil action and a copy of Resolution No. 526 and Resolution No. 534 having been published in an official legal newspaper at least ten (10) days before the 21st day of March, 1961 a hearing was duly held by the City Council of the City of White Bear Lake on the proposed annexation.

III.

The City Council hereby determines and finds:

- (1) That the annexation will be to the best interests of the City of White Bear Lake and of the territories affected.
- (2) That the above-described territories are completely surrounded by land within the municipal limits.
- (3) That the above-described territories are not within any other municipality and are so conditioned as property to be subjected to municipal government.

IV.

Therefore, the City of White Bear Lake hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of White Bear Lake, as effectually as if it had originally been a part thereof.

V.

This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State and from and after its passage and publication.
