ORDINANCE NO. 177

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with City Council of the City of East Grand Forks, Minnesota, by the sole owner of the following described real estate, to have such land included within the City of East Grand Forks, Minnesota:

The South Half of the Southeast Quarter (S $\frac{1}{2}$ SE $\frac{1}{4}$) of Section 36, Township 152 North, Range 50, West of the Fifth Principal Meridian, Polk County, Minnesota.

Section 2. The quantity of land embraced within the foregoing description is 80 acres, more or less.

Section 3. The City Council hereby determines (1) that the annexation will be to the best interests of the city of East Grand Forks, Minnesota; and of the territory affected; (2) that the territory described herein abuts upon the City of East Grand Forks, and is so conditioned as properly to be subject to city government.

Section 4. The corporate limits of the City of East Grand Forks are hereby extended to include the property described in Section 1, and the same is hereby annexed to and included in the City as effectually as if it had originally been a part thereof.

Section 5. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 6. This ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 5.

It was moved by Alderman Paschka and seconded by Alderman Ferguson that the Ordinance be passed and given the number 177.
