

ORDINANCE NO. 1086

An Ordinance Extending the Corporate  
Limits of the City of Albert Lea.

Introduced by Councilman Fred Brabec

The City of Albert Lea Does Ordain:

Sec. 1. A petition has been filed with the governing body of the City of Albert Lea, Minnesota by the owners of the following described real estate to have such land included within the City of Albert Lea, Minnesota:

Neel's Subdivision in the Southeast quarter, Southeast quarter, Section 6, Township 102 North, Range 21 West and in the Northeast quarter, Northeast quarter, Section 7, Township 102 North, Range 21 West.

Sec. 2. The quantity of land embraced within the foregoing description, and bounded as described is 3.92 Acres.

Sec. 3. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Albert Lea, Minnesota and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Sec. 4. Therefore, the City of Albert Lea, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Albert Lea, Minnesota, as effectually as if it had originally been a part thereof.

Sec. 5. This ordinance shall be final and shall take effect and be in force from and after filing certified copies thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
