OF REAL ESTATE FROM THE VILLAGE OF BOYD,
COUNTY OF LAC QUI PARLE, STATE OF MINNESOTA,
UNDER LAWS 1959, CHAPTER 686, SECTION 6,
SUBDIVISION 1.

O R D E R

The Village of Boyd has, by resolution at a regular meeting of the Village Council held April 3, 1961, petitioned for the detachment of certain property adjacent to the village boundary, unplatted, unoccupied and used exclusively for agricultural purposes, hereinafter described, from the Village of Boyd. An identical petition has also been received from all of the owners of the property affected.

The territory involved consists of:

The Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Sixteen (16), Township One Hundred Sixteen (116), Range Forty-two (42), excepting therefrom the tract described by metes and bounds as follows: Beginning at a point on the northeast corner of the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 16, Township 116, Range 42, thence 30 rods due west, thence 16 rods south, thence 30 rods east, thence 16 rods north to point of beginning, and excepting therefrom the railroad right-of-way.

The Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Sixteen (16), Township One Hundred Sixteen (116), Range Forty-two (42),.

The property is unplatted, unoccupied and is used exclusively for agricultural purposes. This detachment would not unreasonably affect the symmetry of the municipality. The land is not needed for reasonably anticipated future development. The petition is in proper legal form and sets forth the information required in Laws 1959, Chapter 686, Section 6, and upon all the files and records, the Commission being fully advised in the premises,
