ORDINANCE NO. 18:00

AN ORDINANCE RELATIVE TO THE ANNEXATION OF CERTAIN LANDS TO THE VILLAGE OF ANNANDALE, MINNESOTA, TO BE KNOWN AS SECTION 18:00.

Section 1. A petition has been filed with the governing body of the Village of Annandale, Minnesota, by all of the owners of the following described real estate to have such land included within the Village of Annandale, Minnesota:

The following described real estate lying in Section 29, Township 121 North, Range 27 West:

Northwest quarter of the Southwest quarter; Northwest quarter of the Northeast quarter; Northeast quarter of the Northwest quarter; and North half of the Northeast quarter excepting that part thereof described as follows: Commencing at the Northwest corner of Section 29, Township 121, Range 27; thence South along the East line of said Section, 635.0 feet to the point of beginning; thence West and parallel with the North line of said section 310.0 feet; thence South in a straight line 492.0 feet; thence easterly in a straight line 323.0 feet to a point on the East line of said Section; thence North along the East line of said Section, 712.0 feet to the point of beginning.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is 102.1 acres.

Section 3. The Village Council hereby determines (1) that the annexation will be to the best interest of the Village of Annandale, Minnesota, and of the territory affected; (2) that the territory described herein meets upon the Village and is so situated as properly to be subjected to Village government.

Section 4. Therefore, the Village of Annandale, Minnesota, hereby ordains and declares that the property hereinafter described to and the same is hereby annexed to, and included in the Village of Annandale, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and from and after its passage and publication.
