

ORDINANCE AMENDING THE CORPORATE LIMITS OF THE  
CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LAND  
NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO CHA-  
TER 606, LAWS OF MINNESOTA, 1959 SESSION (H.S.A. 414.03).

The City of Mankato, Minnesota does ordain:

Section 1.

A petition has been filed with the City Clerk of the City of Mankato, Minnesota, by Clemente V. Scheuror and Anastacia Scheuror, his wife, Lemo Hoine and Anna M. Heise, his wife, sole owners of the following de-  
scribed real estate to have such land included within the City of Mankato,  
Minnesota, to-wit:

The west 793.5 feet of the east 1169.3 feet of the North  
Five (5) acres of the Southwest Quarter (SW $\frac{1}{4}$ ) of the  
Northwest Quarter (NW $\frac{1}{4}$ ) of Section Sixteen (16), Township  
One Hundred Eight (108), Range Twenty-six (26), according  
to the government survey, containing about 3 acres more  
or less.

Section 2.

The quantity of land embraced within the foregoing description is  
unplatted and does not exceed 200 acres and is not within the  
corporate limits of any city or village and is contiguous to and abutting  
upon the boundary of the City of Mankato, Minnesota, an incorporated city,  
having a population of not less than 10,000 nor more than 50,000, pursuant  
to the last census.

Section 3.

The City Council of Mankato, Minnesota hereby determines that the  
annexation of the above described property will be to the best interests  
of the municipality and of the land affected and that the above described  
tract and parcel of land is so conditioned as properly to be subjected to  
city government and is hereby annexed to and declared to be an addition  
to the City of Mankato, as effectually as if it had originally been a part  
thereof and the corporate limits of the City of Mankato, Minnesota are  
hereby extended to include said property.

The City Clerk is hereby directed to file certified copies of this  
ordinance with the Minnesota Municipal Commission, the County Auditor, and  
the Secretary of State and this ordinance takes effect 10 days after its  
passage and publication and upon the filing of certified copies, as herein  
described.
