IT IS HEREBY ORDERED:

(1) The Order of this Court dated and filed February 6, 1961 in the above captioned matter is hereby revoked and set aside.

(2) All appeals of the various parties herein are hereby dismissed with prejudice, without costs or disbursements and the bonds filed herein are released and discharged.

(3) The annexation of the area described in the Order of the Municipal Commission of the State of Minnesota dated February 6, 1961 shall become effective forthwith.
