ORDINANCE 93

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF HORWOOD TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES.

Section 1. A petition has been filed with the governing body of the Village of Horwood, Minnesota by the sole owners of the following described real estate, to have such land included within the Village of Horwood, Minnesota, to-wit:

Commencing at a point 846.2 feet South of the South Quarter corner of Section 11, Township 114 North Range 26 West, being the Northeast corner of Rathfork's Addition, Horwood Village; thence West at an internal angle of $59^{\circ}17'$ for a distance of 486.65 feet to the point of beginning of the tract to be herein described; thence West along said Rathfork's Addition a distance of 527.95 feet to the Northeast corner of the Walter W. Good Tract; thence continuing West at an internal angle of $150^{\circ}49'$ for a distance of 120 feet to the South right of way line of Old State Road #5 and 25; thence Northeast along the said right of way line of said road at an internal angle of $23^{\circ}16'$ for a distance of 716.9 feet; thence Southeast at an internal angle of $87^{\circ}42'$ for 119.5 feet; thence Southwest at an internal angle of $142^{\circ}26'$ for 289.2 feet to the point of beginning.

Lying and being in the Northeast Quarter of the Northwest Quarter of Section 14, Township 115 Range 26 and containing 3 acres of land, more or less.

Section 2. That the quantity of land embraced within the foregoing description and bounded as described, is three acres.

Section 3. The Village Council hereby determines (1) That the annexation will be to the best interest of the Village of Horwood, Minn., and of the territory affected; (2) That the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village Government.

Section 4. Therefore, The Village of Horwood, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to and included in the Village of Horwood, Minn., as effectually as if it had originally been a part thereof.

Section 5. This Ordinance shall be final and shall take effect and be in force from and after filing certified copies thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State and from and after its passage and publication.
