

ORDINANCE No. 501AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN
PROPERTY TO THE CITY OF DETROIT LAKES, MINNESOTA

The City Council of the City of Detroit Lakes, Minnesota,
does ordain:

Section I.

That pursuant to Chapter 636, Minnesota Laws of 1959,
Regular Session (MSA 61A.03, Subd. 7), and all other statutes
in such case made and provided, and upon petition of all of
the owners of that certain property in the County of Becker,
State of Minnesota, and more particularly described as
follows:

A tract containing 26.39 acres in the SW of
the NW of Section 26, Township 139 North,
Range 41, West of the 5th P.M. in Becker Co.,
Minnesota, described as follows, to-wit: Be-
ginning at a point which bears South 89° 25'
East 136.35 ft. from the SE Corner of Block 3
of "Nor-Lake Second Addition", plat of which
is on file and of record in the office of the
Register of Deeds, Becker County, Minnesota;
thence running South 55' West 975.3 ft. to
the South line of the said SW of the NW
of Section 26; thence running Westerly 1170.0
ft. on and along the South line of the said
SW of the NW of Sec. 26 to the SW Corner
thereof; thence running North 55' East 975.85
ft. on and along the West line of the said
Sec. 26 to a point which bears North 89° 25'
West 20 ft. from the SW Corner of Lot 5,
Block 1 of Nor-Lake Second Addition; thence
running South 89° 25' East 1170.0 ft. along
the North line of Northland Street and tangent
extensions thereof to the point of beginning
and there terminating.

Section II.

That it is determined that the annexation will be
to the best interests of the City of Detroit Lakes and
that the above described premises, and the whole thereof,
are declared to be annexed, and to be an addition to the
City of Detroit Lakes, Minnesota.

Section III.

That upon the passage, approval, publication and
filing of this Ordinance as provided by Law, the above
described premises shall become a part of the City of
Detroit Lakes as effectually as if they had been originally
a part thereof.

Section IV.

That the City Clerk of the City of Detroit Lakes
shall cause a copy of this Ordinance to be filed with the

County Auditor, County of Becker, State of Minnesota, the
Secretary of State, State of Minnesota, and with the State
Annexation Commission, all as provided by Law.
