ORDINANCE NO. 34

An Ordinance Annexing Lots 35, 36 and the North 20 feet of Lot 37 in Block 9 of Glenmar, to the Village of Willernie,

THE VILLAGE COUNCIL OF THE VILLAGE OF WILLERNIE DO ORDAIN
AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of Lots Thirty-five (35), Thirty-six (36) and the North Twenty (20) feet of Lot Thirty-seven (37) in Block Nine (9) of Glenmar, said tract containing less than Two Hundred (200) acres, not included in any other village, city or borough, and adjoining the Easterly boundary line of the Village of Willernie, requesting the annexation of said land to said Village, said Petitionhaving been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Willernie are hereby extended to include said land described by the following boundary lines:

Commencing at the Northwest corner of Lot Thirtyfive (35) in Block Nine (9) of Glenmar; thence Easterly
along the North line of said Lot Thirty-five (35) to
the Northeast corner thereof; thence Southerly along
the East lines of Lots Thirty-five (35), Thirty-six
(36) and the North Twenty (20) feet of Lot Thirty-seven
(37) to a point on the East line of said Lot Thirtyseven (37), Twenty (20) feet South of the Northeast Corner
thereof; thence West on a line parallel with the North
line of said Lot Thirty-seven (37) to the center line
of Beaconsfield Road; thence North along the center
line of Beaconsfield Road to a point directly West
of the Northwest corner of said Lot Thirty-five (35);
thence East to Northwest corner of said Lot Thirtyfive (35), being the point of beginning.

and that said territory is hereby made a part of the Village of Willernie as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon filing of a certified copy thereof with the County Auditor of Washington

County and the Secretary of State of the State of Minnesota and with the Minnesota Municipal Commission and from and after its publication.
